Dear Mr. Navn,

This letter agreement confirms the terms on which you have assigned to us with full title guarantee the entire copyright in the Work so as to enable us to exploit the Work by any means at our entire discretion as set out below:-

All other monies not referred to under this agreement: 50%

Royalties are calculated 'at source' throughout the world. At source shall mean all monies received by us in respect of our exploitation of the Work less only sums paid by us to any arrangers and adaptors of the Work, sales tax and monies retained by our sub-publishers, to a maximum of 10% of the total monies earned. Song licenses to affiliates of Publishing Company are issued at statutory rate or customary basis.

**Accounting:** 90 days after the end of June and December.

**Warranties:** You warrant (and indemnify us against breach of such warranties) as follows:

- (i) The Work is a new and original work;
- (ii) The Work is not defamatory or criminally obscene;
- (iii) You have full right and power to enter into this agreement and this assignment qualifies as a certificate for the purposes of the Society's Rule 1(o);
- (iv) You waive all 'moral rights' in the Work;
- (v) Our exploitation of the Work shall not infringe the rights of any third party;
- (vi) You shall execute any documents necessary to confirm our rights hereunder;
- (vii) We may collect all monies earned by the Work prior to the date of this agreement save that we acknowledge that you have received moneys collected by NCB/KODA prior to signing this agreement.

We warrant that we shall use all reasonable endeavours to exploit the Work.

Both parties shall as soon as practicable following execution of this letter agreement conclude a long form single song assignment but until the execution of such document this letter agreement shall be binding on both parties.
